Art. 2 - Selection requirements

The selection is open to those institutions / companies holders of VAT/IVA, who can prove experiences/records:

- in the management and reporting of Creative Europe projects (at least 6 projects);
- in the reporting of European projects with more than 5 partners (at least 8 projects);
- in the reporting of European projects on behalf of Public Bodies (at least 3 projects);
- in the implementation of communication activities in the context of projects financed by European funds (at least 3 assignments).

Written and spoken knowledge of English and French are required.

The applying institution must be legally established in the European Union.

Art. 3 - Duration and amount of the contract

For the global implementation of the provisions of Article 1, Conservatorio Santa Cecilia will provide the contracting institution / company with a global fee equal to a maximum of 44,000.00 Euros gross, inclusive of VAT, R.A and statutory taxes according to the Italian law. This amount does not include travel and subsistence expenses related to the assignment which will be calculated on the basis and within the parameters and amounts established in the project itself. All the mentioned amounts
